Call for Public Comment: Judge Milliron called for public comment on Prison Board Items. There was no comment at this time.

Approval of Minutes: A motion made by Sheriff Ott, seconded by Commissioner Beam that the minutes from the July 19, 2018 Prison Board meeting, are approved as prepared. The motion was unanimously carried.

Abolishment of Clerical Position: The Clerical Position at the Prison has been deemed unnecessary at this point in time.

Work Release Program at the Prison: There was discussion on future plans for the work release program. There are currently 10 participants in the program and the goal is to have 20 before the end of this year. There are employers reaching out to Warden Tate who are interested in working with the Blair County Prison.

3rd Deputy Warden Position: A motion made by Controller Stickel, seconded by Sheriff Ott to take the 3rd Deputy Warden Position to the Salary Board for creation. This motion was unanimously carried.
