## **Blair County Retirement Board Meeting**

**Call to Order:** Commissioner Erb called the meeting to order at 9:00 a.m. and noted that Deputy Controller Angela Wagner is present at today's meeting in the absence of Controller A.C. Stickel.

**Call for Public Comment:** Commissioner Erb called for public comment on Retirement Board Agenda items. There were no comments.

#### **Approval of Minutes:**

A rebalancing option – attached - was provided by Marquette Associates to liquidate \$120,000.00 from the Vanguard Total Stock Market Index and \$60,000.00 from the Fidelity Global ex-US Index Prem. A motion was made by Treasurer Carothers and seconded by Commissioner Webster that the proposal be approved as presented. The motion was unanimously carried.

**Monthly Financial Report**: The Financial Report for December 2019 – attached - was presented by Deputy Controller Wagner for the information of the board.

**Applications for Membership:** A motion was made by Deputy Controller Wagner and seconded by Treasurer Carothers that the applications for membership be accepted as set forth in the agenda. The motion was unanimously carried.
