Call to Order: Commissioner Beam called the meeting to order at 8:34 a.m.

Pledge of Allegiance: Led by Commissioner Beam.

Call for Public Comment: Commissioner Beam called for public comment on Prison Board Items. There were no comments.

Approval of Minutes: A motion was made by President Judge Doyle and seconded by Mr. Consiglio that the minutes from May 16, 2019 Prison Board meeting be approved as prepared. The motion was unanimously carried.

Recognition of BCP Employees: The board recognized the three Deputy Wardens, James Eckard, James McMahon and Jay Whitesel for their excellent performance during her first year as Warden.

Inmate Population Report: Warden Tate provided an updated Inmate Population Report which will be kept on file with the minutes.

Inmate Services Report: Deputy Warden McMahon reviewed the Inmate Services Report which will be kept on file with the minutes. Mr. Consiglio asked the reasons for the number of 182 inmates released. Deputy Warden McMahon explained that reasons include mostly bench warrants and transfers to SCI.

Warden's Report: Warden Tate reviewed the Warden's Report report which will be kept on file with minutes including an update on the Guardian RFID and security cameras projects. Kay Stephens asked what the ultimate goal of the projects is. Warden Tate explained the features and benefits of the Guardian RFID system.

Deputy Warden Eckard provided a Staffing Report which will be kept on file with the minutes.

Meeting of June 20, 2019 continued. . .

Financial Report: Controller Stickel provided a report for May 2019 and will be kept on file with the minutes. It was noted that overtime is at only 40% which is a significant decrease from previous years.

Commissioner Beam noted that prison work crews are performing maintenance tasks including mowing and trimming at two local cemeteries, Oak Ridge and Fairview. Controller Stickel noted that an additional line item will be added to the budget to accept donations and record expenses for this project.

Dr. Silverman from the Prison Society offered to provide an inservice for the judges, warden, and district attorney regarding different approaches to penology.

Adjournment: There being no further business to come before the board, Commissioner Beam adjourned the meeting at 8:56 a.m.




Average Monthly Population – 06/18/2018 to 06/17/2019



Breakdown By Bookings And Releases For Last Two Weeks




Top 10 Charges Of Current Population
