WHEREAS, the Victim Services Program of Family Services Incorporated has led the way in Blair County in addressing sexual assault despite the Covid-19 Pandemic by providing the majority of services unchanged including 24-hour hotline services to victims and their significant others, offering support and comfort to those impacted by sexual assault during criminal proceedings, and empowering those impacted by sexual assault to begin the healing process; and

WHEREAS, ending sexual assault in Blair County must include active public and private efforts, including conversation about what sexual violence is, how to prevent it, how to help survivors connect with crucial counseling and other support services, and how every segment of our society can work together to better address sexual violence; and

WHEREAS, the Victim Services Program has worked to build collaborative relationships between various agencies and organizations to improve the quality of service for those most profoundly and directly impacted by sexual violence, thus setting an important example for how the rest of the community might work together to speak out and find solutions to sexual violence; and

WHEREAS, the Victim Services Program requests public support and assistance as it continues its effort to bring real hope for freeing Blair County from the tragedy of sexual violence to create a future where all women, men and children can live free from violence and exploitation; and

NOW, THEREFORE, BE IT RESOLVED that, we, the Blair County Board of Commissioners, do hereby proclaim the month of April 2021 as **SEXUAL ASSAULT AWARENESS MONTH** and commend this observance to all citizens.

WHEREAS, the month of April 2021 recognized as "Pennsylvania 811 Safe Digging Month", and the initiative sponsored by Pennsylvania 811, a utility notification information center celebrating its 49th year of continuous service to the Commonwealth of Pennsylvania, and

WHEREAS, Pennsylvania 811 received close to 992,000 excavation notifications in 2020, and transmitted approximately 6.6 million notifications to their member facility owners and operators allowing essential utility and construction crews to provide vital underground services and repair of critical infrastructure to communities throughout Pennsylvania, and

WHEREAS, when dialing 811, at least three business days before digging, a homeowner or a contractor is connected to a unique service that notifies the appropriate underground utility operators in the municipality in which the work will be performed, and

WHEREAS, by notifying 811 of their intent to dig, the homeowner or contractor is knowingly helping to protect the underground utilities, themselves, the work crew, and their neighbors from any unsafe digging practices within their community, and

WHEREAS, upon receiving the notification from Pennsylvania 811, the facility owners and operators disperse to the said work site to mark the approximate location of their underground utility lines with flags, paint, or both, to establish an eighteen-inch tolerance zone of the outside wall or edge of their line or facility, and

NOW, THEREFORE, BE IT RESOLVED that, We, the Blair County Board of Commissioners, in support of the Pennsylvania Underground Utility Line Protection Law, PA Act 287 of 1974, as amended, do hereby proclaim April 2021 as "Pennsylvania 811 Safe Digging Month", and encourage all Pennsylvanians to visit the Pennsylvania 811 website at www.palcall.org for information about digging safely.

Chief Clerk Hemminger requested that letter (c) be removed from the Consent Agenda as the invoice would be paid in a different manner and does not need to be handled as a budget transfer.

Motion by Commissioner Webster, seconded by Commissioner Erb and unanimously approved to adopt Resolution #116-2021 with removal of letter (c) from the consent agenda as noted.

Staff Reports & Special Business:

Weekly Covid-19 Update:

Mark Taylor stated that unfortunately the county is seeing a trend of increased positive cases over the past several weeks. He stated that the county has reported two-hundred-two (202) new cases within the past seven-7 days, and the positivity rate increased from 4.7% to 5.9% over the past week.

Mr. Taylor stated that COVID related hospitalizations are remaining study with approximately 15 per day. He stated that area nursing homes and Penn State Altoona are not reporting any major spikes in cases to warrant concern.

Mr. Taylor stated that to date 18,680 Blair County residents have been fully vaccinated and 10,816 residents have received their first dose of the vaccine. He stated that those numbers reflect 2,300 more than the prior week.

Mr. Taylor stated that the Department of Health has rolled out the new vaccination plan, which will allow all Pennsylvanian's eligible to schedule a vaccine by April 19. He stated that the Department of Health has also reduced the number of vaccine providers across the state to three-hundred (300).

Mr. Taylor encouraged everyone to continue safe mitigation practices and to register to receive a vaccine when the appropriate vaccination time comes available.

Park and Recreation Advisory Board:

Joe Keller requested approval of a proposal of service contract received from Keller Engineers, Inc., in the total estimated cost of \$61,000.00 for design, permitting, grant coordination, project coordination, bid documents and bidding, construction administration services and architectural design services associated with the Valley View Park Department of Conservation and Natural Resources (DCNR) grant award for site improvements including amphitheater replacement, ADA access to the amphitheater and parking lot improvements.

Mr. Keller stated that the estimated cost of the contract for design, permitting, grant coordination, project coordination, bid documents/bidding, construction administration and architectural design services in the amount of \$61,000.00, is the same amount included in the grant application. He stated that this amount is within the allowable 15% of the project cost amount.

Discussion followed.

Blair County Bridge's #70 and #82 Replacement Projects:

Brian Wiser requested approval of a proposal of service contract between the County of Blair and Keller Engineers for the Blair County Bridge #70 Phase II/III Environmental Site Assessment and the Blair County Bridge #82 Supplemental Structure Borings, in the total estimated cost of \$72,991.27.

Mr. Wiser stated that the county had been directed by PennDOT to support Engineering Agreement L00343 for design of Bridges #70 and #82 for supplemental services that were determined to be required by PennDOT, but could not be funded through the project's associated Reimbursement Agreement.

Mr. Wiser stated that the Bridge #70 Phase I Environmental Site Assessment (Phase I ESA) resulted in a finding that requires the addition of Phase II/III ESA Services. The Bridge #82 type, size and location report that selected the bridge superstructure type resulted in larger loads being applied to the existing substructure units and further investigation in the form of structure foundation borings are required.

Mr. Wiser stated that sub-consultant, Skelly and Loy, Inc., will provide the Phase II/III ESA Services and sub-consultant, Navarro & Wright Consulting Engineers, Inc., will provide the Structure Boring Services with Keller Engineers providing Project Management and coordination between PennDOT and the sub-consultants,

Discussion followed.

Blair Senior Services:

Dennis Wisor requested approval for the acceptance of the final FY 2019/2020 Medical Assistance Transportation Program (MATP) Grant Agreement, in the total allocation amount of \$1,204,211.00.

Mr. Wisor stated that the Medical Assistance Transportation Program served 1,578 Medical Assistance consumers and provided 53,653 trips. He stated that due to COVID-19 these numbers are significantly lower than previous years.

Discussion followed.

Blair Drug and Alcohol:

Aleisha Albertson requested approval for the submission of the FY 2021/2022 Probation and Restrictive Conditions Grant #35782, in the amount of \$315,000.00, and the 2021/2022 Intermediate Punishment Plan to the Commonwealth of Pennsylvania, Pennsylvania Commission on Crime and Delinquency (PCCD).

Ms. Albertson stated that the grant amount remains the same as last year. She stated that \$95,000.00 supports three-3 APO positions including one-1 position with benefits, and approximately \$60,000.00 for drug testing.

Ms. Albertson stated that she has updated the plan to reflect the random drug testing application now being used and has included the fee for such into the plan.

Discussion followed.

Adult Parole and Probation:

Amanda Moore requested approval of a renewal FY 2020/2021 State Offender Supervision Fund Agreement between the County of Blair and the Commonwealth of Pennsylvania, Board of Probation and Parole for the period of July 1, 2020 through June 30, 2022 for probation and parole personnel for pre-sentence investigations, and for improved adult probation and parole supervision and program services.

Commissioner Erb asked Ms. Moore if the previous year's payment amounts are similar for this year. Ms. Moore stated that the full amount received last year was \$208,736.53, and it is her understanding that the county should be receiving a similar amount. She stated that the payment for the first six-6 months was in the amount of \$104,671.35.

Discussion followed.

Department of Emergency Services/911/E:

a. Mark Taylor requested approval of a License and Services Agreement between the County of Blair, Blair County Department of Emergency Services/911E and RAVE Mobile Safety for the implementation of the Smart 911 Operating System for the period of 03/22/2021 to 03/21/2022, in the total amount of \$32,100.00.

Mr. Taylor stated that the amount reflected for this year is similar to the amount paid last year.

Discussion followed.
