Call to Order:

Commissioner Erb called the meeting to order.

Moment of Silent Reflection:

Commissioner Erb called for a moment of silent reflection.

Pledge of Allegiance to the Flag:

Approval of Meeting Minutes: 05/02/23 and 05/04/23

Commissioner Erb called for corrections or changes to the meeting minutes of 05/02/23 and 05/04/23. **There were no corrections or changes noted.**

Motion by Commissioner Webster, seconded by Commissioner Burke and unanimously approved to accept the minutes as prepared.

<u>CCAP Priority Talk:</u> County Mental Health Base Funding Increase.

Commissioner Erb provided the following overview of the CCAP Priority pertaining to the County Mental Health Base Funding Increase:

"Last week, this Board recognized May as Mental Health Awareness Month.

While awareness of the need to prioritize mental health and the ways the County supports community mental health needs is important, we need to move pass awareness and stress the need for urgent action to rebuild Pennsylvania's crumbling mental health system.

Years of underfunding have left the commonwealth's mental health system in crisis.

Counties are struggling to maintain community-based services such as outpatient treatment for adults and children, crisis intervention, support for individuals leaving state facilities, student assistance programs, and prevention.

Increased support for the community mental health system will improve outcomes for individuals, allow for prevention and treatment where people need it most, help prevent individuals from more significant impacts like going to the hospital emergency department, provide crucial support for children with complex behavioral health needs, and begin to address the growing issue of the county prison serving as a de-facto mental health facility as Commissioner Burke discussed two weeks ago.

The crisis in Blair County will be further exacerbated with the Medicaid eligibility changes due to the ending of the public health crisis.

Blair HealthChoices Executive Director Amy Marten-Shanafelt estimates that 6-7,000 county residents will lose their Medicaid coverage, which will add more burdens and costs to the county's mental health system.

In 2010, Blair County's Mental Health Base Funding was around \$4.1 million. This year it is less than \$3.7 million, even as costs have risen significantly.

Thanks to the flexibility of the county mental health base funding and good management by the county's Mental Health office, our residents continue to receive services.

But, those funds are now stretched to the breaking point.

However, there is some good news in Governor Shapiro's proposed budget.

The governor proposed a \$20 million increase in county mental health base funding for FY 2023-24, with additional funds in successive years, reaching a \$60 million increase by FY 2027-28.

We appreciate this proposed increase as it addresses a top CCAP priority for 2023 and a long-time goal for increased mental health base funding.

But, this would only serve as a down payment toward a long-term commitment to counties, who need funding to rebuild the crumbling mental health system and shore up the social services safety net.

CCAP is asking the Administration and General Assembly to make a more significant investment in rebuilding Pennsylvania's mental health system by increasing the county mental health base by \$150 million.

To build the \$20 million increase proposed by Gov. Shapiro to \$50 million,

To redirect the Governor's proposed \$100 million mental health increase for schools into the county mental health base to improve coordination for better outcomes,

And, to invest the \$100 million in federal American Rescue Plan Act funding allocated for mental health consistent with their Commission's recommendations.

The commonwealth needs to commit to a long-term plan of further increases over the next five to ten years to pull Pennsylvania's mental health system from the point of collapse to a system that fully meets the needs of its citizens."

Public Comment:

Commissioner Erb called for public comment.
