Proclamations: Sexual Assault Awareness Month

National Library Week 2023

Commissioner Burke read the following proclamation:

Proclamation Sexual Assault Awareness Month – April 2023

WHEREAS, sexual assault is an intolerable violent crime with public health implications for every person in Blair County regardless of the age, gender expression, sexual orientation, race, ethnicity, religion, disability, or socioeconomic status of a victim, family member, or significant other of a victim; and

WHEREAS, no one single person, organization, agency or community can eliminate sexual assault on their own—we must work together to educate our entire population about what can be done to prevent sexual assault, support victims and their significant others, and increase support for agencies providing services to victims; and

WHEREAS, ending sexual assault in Blair County must include active public and private efforts, including conversation about what sexual violence is, how to prevent it, how to help survivors connect with crucial counseling

and other support services, and how every segment of our society can work together to better address sexual violence; and

WHEREAS, the Victim Services Program of Family Services Incorporated leads the way in Blair County in addressing sexual assault by continuing services including 24-hour hotline services to victims and their significant others, offering support and comfort to those impacted by sexual assault during criminal proceedings, and empowering those impacted by sexual assault to begin the healing process; and

WHEREAS, the Blair County District Attorney's Office of Victim/Witness serves as a direct line of communication between sexual assault victims and the prosecutors who battle to achieve accountability in the criminal justice system, allowing a sexual assault victim's voice to be heard and heeded by both judge and jury in the courtroom; and

WHEREAS, the national statistics demonstrate that justice for sexual assault victims has been elusive in our country since only 5% of all sexual assaults lead to arrest and only 3% of all sexual assaults result in a conviction, the Blair County District Attorney and his Assistants have committed to transforming Blair County into a safer haven for victims than the rest of the nation by prioritizing sexual assault prosecutions in Blair County through trauma-informed interactions with victims; through working in lockstep with law enforcement to strengthen investigations that pave the way for effective arrests and successful prosecutions; and through zealous courtroom advocacy to secure convictions from Blair County juries and strong sentences from Blair County judges; and

WHEREAS, the Victim Services Program, the Blair County District Attorney's Office Victim/Witness program, and the Blair County District Attorney along with his assistant prosecutors have all worked together to build collaborative relationships to improve the quality of service for those most profoundly and directly impacted by sexual violence, thus setting an important example for how the rest of the community might work together to speak out and find solutions to sexual violence; and

WHEREAS, the Victim Services Program, the Blair County District Attorney's Office Victim/Witness, and the Blair County District Attorney requests public support and assistance as they continue their efforts to bring real hope for freeing Blair County from the tragedy of sexual violence to create a future where all women, men, and children can live free from violence and exploitation; and

NOW, THEREFORE, BE IT RESOLVED that we, the Blair County Board of Commissioners, do hereby proclaim the month of April 2023 as SEXUAL ASSAULT AWARENESS MONTH and commend this observance to all citizens.

Motion by Commissioner Burke, seconded by Commissioner Webster and unanimously approved to adopt the Proclamation.

Alex Ross Schnaubelt shared a few brief words and thanked the board for the recognition. He stated that a lunch and learn would be held on Friday, April 28, 2023 at the American Legion Social Hall in Hollidaysburg, PA from 11 am until 2 pm and that reservations for the event can be made by visiting their website www.familyservicesinc.net

Commissioner Webster read the following proclamation:

Proclamation National Library Week 2023

WHEREAS, libraries are more than book repositories, demonstrating the breadth and depth of all they offer to their communities, with opportunities for community engagement, learning and growth while delivering new services which more closely connect to residents and their needs;

WHEREAS, libraries throughout Pennsylvania have consistently served as valued and needed institutions, and library staffs and volunteers strengthen these centers by fueling their efforts to enhance the surrounding community;

WHEREAS, the Pennsylvania Library Association is the state's oldest and most diverse professional library organization serving libraries, library employees, library trustees, and Friends of the Library groups working to heighten awareness of the various tools and resources, such as STEM programming, workforce development and life planning tips libraries offer;

WHEREAS, collectively we recognize librarians as information professionals who provide expertise, services and guidance for patrons to access credible sources and material, making their own informed decisions about the worlds they navigate;

WHEREAS, librarians level the playing field for anyone who seeks information and access to technologies, particularly as society continues to transition the way in which information is shared and explored in the online world;

WHEREAS, the Pennsylvania Library Association's PA Forward initiative provides a collective voice for the state's libraries to tell their own stories, building capacity for the work they do with and for patrons through five literacies – Basic, Information, Civic and Social, Health and Financial – underscoring the importance of lifelong learning;

WHEREAS, Pennsylvania libraries support democracy and effect social change through their commitment to providing equitable access to information for all library users regardless of race, ethnicity, creed, ability, sexual orientation, gender identity or socio-economic status;

WHEREAS, April 25 is National Library Workers Day, a day for all library staff, volunteers and supporters to highlight the immeasurable contributions made by libraries; April 26 is National Library Outreach Day, a day recognizing the importance of libraries being available beyond their physical structure; and April 27 is Take Action for Libraries Day, a day which encourages everyone to recognize how libraries enhance communities and quality of life;

NOW, THEREFORE, be it resolved that the Blair County Board of Commissioners proclaim National Library Week, April 23-29, 2023 in Blair County. Residents are encouraged to visit their local libraries this week and beyond, exploring all that libraries have to offer, realizing that literacy is power and that libraries provide the fuel to move Pennsylvania forward.
