## **Staff Reports & Special Business:**

# Weekly Covid-19 Update:

Mark Taylor stated that he is happy to report that since his report last Tuesday, February 9<sup>th</sup> there has only been an increase of 1,200 new cases reported by the Department of Health for the Commonwealth of Pennsylvania which is a much smaller number than what has been previously reported. He stated that the county's positivity rate also decreased to 7.6% and the number of patients hospitalized with a COVID-19 diagnosis is twenty-eight (28). However, the county did unfortunately see ten (10) additional COVID-19 related deaths since last reporting.

Mr. Taylor stated that even though statistics are improving, residents must still be diligent in taking all necessary precautions against the virus (i.e., masking, social distancing, sanitizing, handwashing, etc.) He is happy to report that cases are improving in area nursing homes and prisons with some nursing homes opening up for family visitation.

Mr. Taylor stated that the 5-day COVID testing recently held by AMI at the Blair County Convention Center only had a response of two-hundred-sixty-nine people. He stated that he was very disappointed in the turn out number, and encouraged all to be tested regardless of symptoms or not.

Mr. Taylor stated that Conemaugh Nason Hospital sponsored a vaccine clinic for the 1A group on Friday, February 12, 2021. The clinic vaccinated well over 1,000 pre-registered individuals in a 12-hour span.

Mr. Taylor encouraged everyone wishing to receive the vaccine to remain in daily contact with his or her local pharmacy and physician's office. He stated that once the county receives word that they will be receiving a sufficient quantity of vaccine, plans are ready to go to establish a mass distribution site at the Blair County Convention Center.

#### **Children, Youth and Families:**

Jim Hudack requested approval to exercise the second of two one-year extension terms pursuant to Section 1.02 of the current lease agreement between the County of Blair, Blair County Children, Youth and Families and JJ Keller Family Limited Partnership extending the lease through February 28, 2022 for Offices 120-129 located at 317 Union Street, Hollidaysburg, PA.

Mr. Hudack stated that the request is for the second of two one-year extension terms to the current lease agreement with JJ Keller Family Limited Partnership to extend the lease agreement an additional year to February 28, 2022 for the CYF Offices located at 317 Union Street, Hollidaysburg, PA. He stated that all other terms of the lease agreement remain the same and that utilities are included in the monthly rental fee. Mr. Hudack also stated that the CYF Needs Based Budget with no charge to the county pays for the lease.

Discussion followed.

## **Court Administration:**

a. Scott Schultz requested approval for the submission of a Project Budget Modification request, Sub-grant #2020-CE-01-33335, to the Pennsylvania Commission on Crime and Delinquency (PCCD), transferring a total amount of \$17,160 from the Clorox wipes, face masks, face shields, head sets, internet speed, and microphone covers category, to the audio/visual equipment, printers, televisions and pager system category for the purchase of television carts, cables and speakers, and printers for the court rooms to be able to print and scan cost and fines sheets for each court room, and televisions to be able to hold video hearings in the court rooms, and a pager system for the MDJ's to be able to help with social distancing for individuals who appear for hearings.

Mr. Schultz stated that the overall grant total is not changing. He stated that the request is just for the transferring of funds among various line items.

Discussion followed.

b. Scott Schultz requested approval for the acceptance of the Pennsylvania Commission on Crime and Delinquency's (PCCD) award of additional grant funds, Sub-grant #2019-OG-DC-31123, in the total amount of \$6,053.00, for Drug Testing and Continuation of Education. Original grant award amount increased from \$131,670.00 to \$137,723.00.

Mr. Schultz stated that PCCD approved the county's request for an increase in grant funds in the total amount of \$6,053.00 to be used for drug testing patches. He requested that the board consider accepting the award of additional grant funds.

Discussion followed.

## **Logan Township:**

Nicole Hemminger requested approval for a letter of support for the submission of a Southern Alleghenies Regional Greenways Mini-Grant Application by Logan Township, Blair County for the Leopold Park Train Viewing Area Project.

Chief Clerk Hemminger stated that Logan Township is once again requesting a letter of support for the submission of a Southern Alleghenies Regional Greenways Mini-Grant Application for the Leopold Park Train Viewing Area Project, as their prior year grant submissions were unsuccessful. She stated that there is no funding from the county associated with this grant.

Discussion followed.

## Finance:
