#### A. Audit 2020:

Discussion concerning a deadline extension for the completion of the 2020 audit by Young, Oakes, Brown and Company (YOBCO).

### B. Blair County Drug and Alcohol:

Requesting approval of the FY 21/22 Provision of Single County Authority (SCA) Functions Agreement between the County of Blair and Blair County Drug and Alcohol for the period of July 1, 2021 through June 30, 2022.

#### C. Blair Senior Services:

Requesting approval of the FY 20/21 fourth Quarter Medical Assistance Transportation Program (MATP) Report.

## D. **Department of Emergency Services:**

Requesting approval of a Facility Event Agreement between the County of Blair, on behalf of the Department of Emergency Services and the Blair County Convention Center, for use of the Allegheny Lobby, Grand Lobby, and Ballrooms 1, 2 & 3 and meal catering services on April 6, 2022 for the annual Local Emergency Planning Committee (LEPC) SARA Summit. Costs associated with this event shall not exceed \$12,000.00 and will be paid with Hazardous Materials Protection Program Funds.

#### E. Victim/Witness:

Requesting approval for the acceptance of a Pennsylvania Commission on Crime and Delinquency (PCCD) Victim/Witness RASA Subgrant Award #34642, in the total amount of \$200,869.00, for the period of January 1, 2021 through December 31, 2022.

#### F. Children, Youth and Families:

a. Requesting approval of a Lease Agreement between the County of Blair and JJ Keller Limited Partnership for lease of offices 120 through 129, located at 317 Union Street, Hollidaysburg, PA to be used as offices of Blair County Children, Youth and Families (CYF), for the term of three (3) years commencing on July 1, 2021 and ending on June 30, 2024 for the annual rental or sum of \$23,700.00, in equal monthly payments of \$1,975.00 beginning July 1, 2021 as specified in Article 2 of said Lease Agreement. Lessor may increase the annual rent by up to four (4%) percent on the first day of any Extension Term.

- b. Requesting approval of an allocation of funding under the Promoting Safe and Stable Families Caseworker Visitation Program under Title IV-B of the Social Security Act, (42 U.S.C. §§ 629-629i) in the total amount of \$2,786.00, for the period of October 1, 2020 through September 30, 2021. Funds are to be used to improve the quality of caseworker visits with children in foster care with an emphasis on improving caseworker decision-making on the safety, permanency and well-being of foster children, and on activities designed to increase recruitment, retention and training of caseworkers.
- c. Requesting approval for Blair County Children, Youth and Families (CYF) to conduct a Workforce Development Training Day at White Oak Hall, Fort Roberdeau on September 17, 2021. Costs associated with the training day will be paid using the Promoting Safe and Stable Families Caseworker Visitation Program funds allocation, in an amount not to exceed \$2,786.00.
- d. Requesting approval of a Memorandum of Understanding (MOU) between the County of Blair, on behalf of Blair County Children, Youth and Families (CYF) and Kids First Affiliated Services, LLC to implement the Healthy Families America (HFA) evidence-based home visiting program with fidelity to the program model. Said MOU relates to the procedural cooperation of all parties with respect to the HFA and does not modify or replace any written contract said parties have entered with respect to other matters.
- e. Requesting approval of a Software License Agreement upgrade between the County of Blair, Blair County Children, Youth and Families (CYF) and intuit QuickBooks, for five (5) QuickBooks Enterprise Silver Users, in the annual amount of \$3,566.00. Said annual amount has an estimated 10% price increase per renewal period.

#### G. Social Services:

Requesting approval of a Sub-Recipient Agreement between the County of Blair, and the Center for Community Action Agency for Pennsylvania Housing Affordability and Rehabilitation Enhancement (PHARE) Funds for FY 20/21, in the amount of \$15,000.00, for housing stabilization activities within the County of Blair, for the period of August 31, 2021 through August 31, 2022.
