#### **Staff Reports & Special Business:**

## **Emergency Services:**

COVID-19 update by Mark Taylor.

Mr. Taylor stated that the number of COVID-19 positive cases continues to climb within Blair County mainly due to wide community spread. He stated that since his report last week there have been 646 new cases within Blair County with 225 just over the weekend. The number of hospital inpatients with the virus is the highest it has been since the beginning of the Pandemic.

Mr. Taylor stated that the testing site opened up at the Convention Center and 575 per tested on Sunday with an additional 505 tested on Monday.

Mr. Taylor encouraged everyone to take precautions and adhere to the CDC and Department of Health's guidelines in order to help stop the spread of the virus.

#### **Social Services:**

a. Trina Illig requested authorization of Commissioners signatures to submit a budget revision (#3) to The Commonwealth of Pennsylvania, Department of Community & Economic Development. For, Emergency Solutions Grant (ESG) FY2019 Contract #C000072744, on behalf of Blair County Community Action, and Family Services, for Rapid Rehousing.

## **Blair County Community Action Agency**

- Decrease existing activity for Financial Assistance from \$6,573 to \$5,586 for a total net decrease of -\$987.00
- Increase existing activity for Rental Assistance from \$37,312 to \$38,299 for a total net increase of \$987.00

Mrs. Illig stated that the requested budget revisions are a basic "clean up" of FY 2019 spending.

  - Housing Assistance Program \$30,000.00
  - Childhood Lead Poisoning Reduction Program \$120,000.00

Mrs. Illig stated that the grant is a statewide competitive grant. She stated that regarding Housing Assistance, there are currently many open programs offering grants.

Motion by Commissioner Erb, seconded by Commissioner Webster and unanimously approved to adopt Resolution 472-2020.

#### **Court Administration:**

- a. Janice Meadows requested approval of a quote between the County of Blair and Empire, to remove and replace the amplification in courtroom #5 between the chambers, in the amount of \$2,478.00. Discussion followed.
- b. Janice Meadows requested approval for the annual renewal of a support agreement for the court reporter software program for their voice writing equipment, in the amount of \$3,395.00 for a period of December 10, 2020 to December 9, 2021.

Mrs. Meadows stated that this is an annual request and that the rate remained the same as last year.

Discussion followed.

# **Blair Drug and Alcohol Partnerships:**

Aleisha Albertson requested approval for the submission of the FY 2020-2021 Intermediate Punishment Treatment Program grant # 34290, in the amount of \$315,000.00 from the Pennsylvania Commission on Crime and Delinquency.

Ms. Albertson stated that it should be noted that the grant application was previously submitted and today's request is for the acceptance of the awarded amount of \$315,000.00. She stated that the awarded funds would benefit the Drug Court and DUI Court Program for the period of July 1, 2020 through June 30, 2021.

Discussion followed.

#### **Emergency Services/911E:**

a. Kellie Novak requested approval for the renewal of a maintenance and warranty agreement between the County of Blair, Department of Emergency Services/911E and Gen-Mark, formally known as Renmark and Schneider Electric, in the amount of \$4,975.00 for the period of November 1, 2020 through October 31, 2021.

Ms. Novak stated that this is an annual request and that there was a slight increase in the rate of from last year. She stated that this agreement supports the VA Galaxy 5000 uninterrupted power supply system consisting of thirty-six (36) batteries.

Discussion followed.

b. Cris Fredrickson requested approval to purchase a 60-Day Stockpile of Personal Protective Equipment (PPE) that is directly related to the performance of otherwise eligible emergency work, or is provided to healthcare workers, patients with confirmed or suspected COVID-19 infection, and first responders, *pursuant to Resolution 122-2020 Declaring a Disaster Emergency (COVID-19 Pandemic)* as outlined in (Section C, 4, g, i), FEMA Policy 104-009-19-PA-Eligibility-Policy-COVID. Said purchase will be reimbursed at 75% through FEMA disaster grant funds, and 25% through PEMA disaster grant funds.

Mrs. Fredrickson stated that the Personal Protective Equipment would be purchased from a CoStar's vendor; however, she is unable to provide a dollar amount of the purchase at this time stating quotes are only good for the day the quote is obtained. She stated that the amount of PPE purchased will be based on the average burn rate (rate of use) over the last few months.

Discussion followed.

## **Juvenile Probation:**

Jon Frank requested approval for the submission of the FY 2020-2021 Juvenile Court Judge's Commission Grant-In-Aid Notification/Invoice (#G-20-21-7), in the amount of \$52,370.43 for reimbursement of Juvenile Probation Services for the period July 1, 2020 through June 30, 2021.

Mr. Frank stated that the grant funds are for the operation of juvenile probation services and that today's request for signatures to the invoice will enable the release of grant funds to the county, in the amount of \$52,370.43.

Discussion followed.

#### Elections

Don Weakland requested approval of a proposal received from Empire for the installation/configuration of equipment necessary to provide up to 5G of cellular service to the highway/elections office at the Blair County highway yard, in the total amount of \$25,793.00, with 50% due upon receipt of purchase order and the remainder due at project completion.

Mr. Weakland stated that there are currently numerous "dead spots" in cell service at the highway and election offices located at the highway yard. He stated that the proposal received from Empire would provide for complete coverage of the building.
