Department of Emergency Services:

i. Cris Fredrickson requested approval of the FFY 2019 Hazard Mitigation Grant Agreement (HMGP) between the County of Blair, on behalf of the Department of Emergency Services and the Pennsylvania Emergency Management Agency (PEMA), on behalf of the U.S. Department of Homeland Security (DHS) and the Federal Emergency Management Agency (FEMA), in the total amount of \$105,000.00, for the performance period of August 6, 2022 through August 5, 2025.

Mrs. Fredrickson stated that the funds would reimburse the county for work and projects to update the current County Hazard Mitigation Plan.

Discussion followed.

ii. Cris Fredrickson requested approval for the completion, signature and submission of the online Tier II Submission Form for chemicals onsite at the Blair County 911E Center for the period of January 1, 2022 through December 31, 2022.

Mrs. Fredrickson stated that the submission will require a signature on the report and the Fee Exemption Form after the online submission is completed.

iii. Cris Fredrickson requested approval for the Blair County Department of Emergency Services to issue a Request for Proposal (RFP) for Reverse 911 Services during the period of March 10, 2023 through May 29, 2023 with a contract award on or before October 30, 2023.

Mrs. Fredrickson stated that an RFP would be sent to various Reverse 911 platforms for comparison of available services and pricing.

iv. Ms. Wink stated that awarded funds are used for personnel, employee benefits, supplies and operating expenses associated with the operation of the Juvenile Probation Office's Victim/Witness Program.

Social Services:

Commissioner Erb requested approval for the submission of a Designation of Signing Authority for the Community Development Block Grant (CDBG) and HOME Grant Contract #C000084484, authorizing Tricia Maceno, Director, Blair County Department of Social Services, as the delegated individual signing authority to submit any financial invoices for the duration of the contracts activity period of December 6, 2022 through December 5, 2026.

Discussion followed.

Prison:

i. Jay Whitesel requested approval for Ratification of Jeff Plazek's signature on a Service Order received from Joseph T. Berrena Mechanicals, Inc. to service the prison's Milnor Washer, in the total amount of \$305.00.

Discussion followed.

ii. Jay Whitesel requested approval to complete the US Food's Premier Foodservice Program Enrollment Form and to accept the Program Terms and Conditions in order to access the program's many contracted manufacturer agreements as a current OMNIA Partner's Public Sector Participant.

Deputy Warden Whitesel stated that the Premier Foodservice Program is a proven twenty-20 year program that will offer the county access to product savings thru many participating vendors. He stated that the program takes a comprehensive approach to delivering value, combining sole-source distribution through U.S. Foods and Premier's many contracted manufacturer agreements.

Discussion followed.

Public Works/Building Maintenance:

i. Jim Pooler requested approval of a Proposal received from Empire for complete system support for the door swipe system for 2023 for the Blair County Courthouse, Highway Department and 911 Center, in the total annual amount of \$22,158.00, billed quarterly in the amount of \$5,540.00, for a period of one-1 year from the date of acceptance.

Mr. Pooler stated that Empire would provide complete system support for the door swipe system at the courthouse, highway department and the 911E Center.

Discussion followed.

- ii. Jim Pooler requested approval of a Proposal received from JM Young & Sons, Inc., to cover any repair outside of the warranty coverage on the roof of the 1999 side of the courthouse and the prison roof at the following rates:
 - Hourly rate for travel and repairs is \$50.00 per hour (about 2 hour round trip)
 - T-Joint Patch \$11.30 each
 - Quick Seam Corner \$15.33 each
 - PS4020 \$4.20
 - Tube of Lap Sealant \$20.17 each
 - 9" Flashing \$9.36

Mr. Pooler stated that the proposal would cover repairs outside of the warranty coverage for the 1999 side of the courthouse and the prison roof.

Katherine Swigart requested approval of the policies within the new County of Blair Employee Handbook.

Miss Swigart provided for board review a summary of the policy changes made since the last draft revised by labor counsel.

Miss Swigart indicated that there were outstanding questions on the following four-4 policies:

Commissioners Office:

Allison Senkevich requested approval for execution and signature on the 2022 Multimodal Transportation Fund Grant Reimbursement Agreement for highway and bridge projects by and between the County of Blair and the Commonwealth of Pennsylvania acting through the Pennsylvania Department of Transportation (PennDOT).

Mrs. Senkevich stated that the Reimbursement Agreement is for the Multimodal Transportation Fund Grant awarded to the county, for \$2 million to improve a section of the Blair County Road 101 corridor.
