Approval of Meeting Minutes – 05/11/21 and 05/13/21:

Commissioner Erb called for corrections or changes to the meeting minutes of 05/11/21 and 05/13/21. There were no corrections or changes noted.

Motion by Commissioner Burke, seconded by Commissioner Webster and unanimously approved to accept the minutes as prepared.

Public Comment:

Commissioner Erb called for public comment. There were no comments noted.

Commissioners Comments:

Commissioner Erb called for commissioners comments.

Commissioner Webster no comments presented.

Commissioner Burke announced the Senator Bob Casey will be in Altoona for a town hall meeting. Commissioner Burke invited all to attend the town hall meeting.

Commissioner Erb stated that the county is expecting the first payment of the ARP Act monies to arrive in the county in the next month or so. The only guidance that has been clear from the US Treasury is that broadband expansion is an eligible expenditure.

Special Presentation – Efforts of Alleghenies Broadband, Inc.:

Jim Foreman stated the purpose of forming Alleghenies Broadband Inc. (ABI) was to strengthen the Broadband service within Blair County and all the Counties in the South Central Region. The goal is to not only improve internet access for the underserved area of the County but also provide access to the unserved. This would include both Internet Speed and Internet bandwidth.

Mr. Foreman ensured the Commissioners that any Blair County dollars contributed to the effort would be spent only on Blair County projects. ABI's vision is to work collaboratively with the schools and municipalities with in the County to partner and share in the cost of improved service to residents.

Brandon Carson stated that in the Blair County Comprehensive Plan that lack of good internet/broadband service was a deficiency in nearly all areas of the County and the same is true for all counties in the South Central Region. ABI was formed with representatives from all counties who have worked together to form short and long term goals for broadband expansion as well as apply for funding streams to achieve the goals.

Short term plans such as retrofitting existing towers and upgrading current equipment as well as long term goals such as installation of fiber would benefit both unserved and underserved populations. ABI has developed proposals that would implement both short and long term goals. The proposals will soon be ready for solicitor review. Each proposal has a clause that relies on state and federal grant or American Rescue Plan (ARP) Act money to be available for the project to be completed.

Steve McKnight spoke in the importance for broadband availability for not only schools and healthcare providers but for the economic impact as well. Broadband expansion is a necessary and key factor in driving economic development which is a priority for ABCD Corp. Mr. McKnight joined Mr. Foreman and Mr. Carson's request for the Blair County Board of Commissioners to consider using ARP funds to support ABI's efforts to expand Broadband access.

<u>Proclamation – June 7-11, 2021 Child Welfare Professionals Appreciation Week:</u>

Commissioner Burke read the following proclamation:

Blair County Proclamation Recognizing The Staff of Blair County Children, Youth & Families June 1, 2021

WHEREAS, the week of June 7-11, 2021 has been proclaimed as Child Welfare Professionals Appreciation Week by Governor Wolf, recognizing the efforts of child welfare professionals serving the children of Pennsylvania; and

WHEREAS, every day in Blair County, local children are at risk of child abuse and neglect or have been removed from their homes due to such abuse and neglect; and

WHEREAS, we, the Commissioners of Blair County recognize the risks and the need to protect the children in the Commonwealth; and

WHEREAS, the challenging task of investigating child abuse, providing services to families, assessing safety, and providing services to ensure that the children of Blair County are provided with nurturance, family connections, support as they transition into adulthood, and services that allow a child to remain safely in their home or return home as expeditiously as possible made more challenging by the global pandemic falls to the child welfare professionals of Blair County's child welfare system; and

WHEREAS, the work of child welfare professionals may require them to enter into situations in which their personal safety may be put at risk; and

WHEREAS, the work of child welfare professionals of Blair County require them to take on the role of frontline essential workers in the time of a global pandemic and provide services to the families of Blair County despite the risk to the professional's health and safety; and

WHEREAS, child welfare professionals work in difficult and emotional situations with children who have been victimized by physical abuse, sexual abuse, neglect, and other forms of maltreatment; and

WHEREAS, the professionals of Blair County Children, Youth & Families must develop great skill in working with families who are in crisis situations, struggling with mental health challenges, suffering from drug and alcohol afflictions, poverty, and other difficult issues; and

WHEREAS, the professionals of Blair County Children, Youth & Families must develop substantial knowledge and skills surrounding the rights of families, the laws surrounding child welfare, and the legal processes governing the system; and

WHEREAS, the staff of Blair County Children, Youth & Families selflessly undertake the endeavor to protect Pennsylvania's children, often with low pay, long hours, tremendous demands, little appreciation, great criticism, and with dramatic impacts to their personal life; and

WHEREAS, every year, child welfare professionals are injured or killed in their pursuit to protect children across the United States; and

WHEREAS, the Coronavirus epidemic has created substantial challenges in providing child welfare services to which the staff of child welfare rose most proficiently; and

WHEREAS, innumerable injuries and deaths of children in Blair County have been averted due to the efforts of Blair County Children, Youth & Families; therefore, in special recognition of the efforts of Blair County Children, Youth & Families serving the children of Blair County, We, the Commissioners of Blair County, do hereby issue this Proclamation recognizing the staff of Blair County Children, Youth & Families for their dedicated efforts in protection the children of Blair County.

Weekly COVID-19 Update:

Mr. Taylor stated that there were only seventy-seven (77) new positive cases to report since last week; the cases per hundred is down to 63.2; the positivity rate is down from 6.7% to 5.3%; and the number of patients hospitalized due to COVID-19 are also down to under fifteen (15). Sadly, there two (2) additional deaths.

Mr. Taylor stated that the monitoring trends seem to be headed in the right direction. He stated that the key to keep heading in the right direction is to continue encouraging vaccinations. There is plenty of vaccine available and that onsite clinics can be set up.

Mr. Wiser stated that the lump sum total and expenses is in the amount of \$1,730.00.

Bridge #73/Mountain Road:

Brian Wiser requested approval of proposal received from KTA-Tator Inc. for NACE Coating Inspection Services in the Quality Assurance Role for Bridge #73/Mountain Road, Blair County, PA, in an amount not to exceed \$10,000,00.

Mr. Wiser stated that KTA-Tator Inc. will provide a NACE Certified Inspector (CWI) who will perform the NACE Coating Inspection Services of the fabrication structural steel for the Bridge #73/Mountain Road repair project.

Mr. Wiser stated that the inspection services will take place at the Regal Industries Facility located in Donora PA. He stated that the anticipated coating inspection duration is estimated at 80 hours of production time in an amount not to exceed \$10,000.00.

Department of Social Services:

a. Melissa Gillen requested approval of an Affordable Housing Trust Fund Program Disbursement for an allocation amount not to exceed \$50,000.00 for Owner Occupied Rehabilitation through the County of Blair, with a cap of up to \$10,000.00 per unit, administered through the Community Development Programs administered within the Blair County Department of Social Services.

Ms. Gillen stated the allocation has been approved by the Affordable Housing Trust Fund (AHTF) Advisory Board on May 12, 2021.

Discussion followed.

b. Melissa Gillen requested approval to modify the disbursement of Affordable Housing Trust Funds for the Weatherization/Housing Rehabilitation Program increasing the cap amount from \$5,000.00 to \$10,000.00.

Ms. Gillen stated that the Affordable Housing Trust Fund (AHTF) Advisory Board voted to request Commissioner's approval to increase the cap amount from \$5,000.00 to \$10,000.00 for the Weatherization/Housing Rehabilitation Program. She stated that the current cap of \$5,000.00 is insufficient as most weatherization requests are exceeding the cap amount.

Chief Clerk Hemminger stated that the county received notification that the PCoRP Underwriting and Claims Committee approved the county's 2020/21 PCoRP Loss Prevention Grant Application in the amount of \$20,000.00.

Chief Clerk Hemminger stated that the grant funds will be used for the purchase of parts and labor to upgrade the existing Simplex fire alarm panel.

Facility Maintenance:

Jim Pooler requested approval of a proposal received from Johnson Controls, in the total amount of \$20,945.00, for the purchase of parts and labor to upgrade the existing Simplex Fire Alarm Panel. \$20,000.00 of the total cost will be paid with awarded PCoRP 2020/2021 Loss Prevention Grant Funds, and the remaining \$945.00 will be paid from the Facility Maintenance Budget.

Mr. Pooler stated that the existing Simplex Fire Alarm Panel reached its end-of-life status in 2002 and the replacement parts for the existing fire alarm panel were liquidated and discontinued as of December 31, 2017.
