Call to Order:

Commissioner Erb called the meeting to order.

Moment of Silent Reflection:

Approval of Meeting Minutes: 05/09/23 and 05/11/23

Commissioner Erb called for corrections or changes to the meeting minutes of 05/09/23 and 05/11/23. **There were no corrections or changes noted.**

Motion by Commissioner Webster, seconded by Commissioner Burke and unanimously approved to accept the minutes as prepared.

Public Comment:

Commissioner Erb called for public comment.

Eric Kay, Veterans' Affairs Director and Jim Pooler, Public Works/Building Maintenance Supervisor, requested that the board consider allowing the exterior lighting of the courthouse to be light red, white and blue May 27 through May 30, 2023 in observance of the Memorial Day Holiday.

CCAP 2023 County Government Priority:

Children and Youth with Complex Behavioral Health Issues

Commissioner Burke provided the following overview of the CCAP 2023 County Government Priority:

Addressing the Needs of Children and Youth with Complex Behavioral Health Issues:

We have talked before about the increase in the number of complex cases that CYF & Social Services work on and the degree of complexity involved in the cases. This increase in complexity is a large part of the burn out experienced by workers in many related industries including nursing, teaching, and social work. In professions where the goal is to help people, and especially children, there are tremendous barriers preventing us from achieving success.

Simply defined complex cases are those where a child experiences an intersection between mental health, substance abuse (whether their own or that of a caregiver) and/or developmental disability. Sometimes, older children also have involvement with the juvenile justice system, which adds yet another layer of complexity.

Although the system favors keeping kids with family and in familiar situations in order to reduce trauma, there are situations where placement is necessary because the child's needs cannot be met in the community or because there is a safety issue that cannot be mitigated without placement. However, we lack appropriate options for placements for kids with complex needs. Anecdotally we have heard of other child welfare agencies licensing their own employees' homes as foster care so they can send children home with workers. Here in Blair County when we are unable to find placement for a child they stay in our office during the day unless we can find an in person educational resource for them. Overnight they stay in hotels and are monitored by two staff members at a time. We have had at least two situations in the past year where this was necessary.

This is not only an immense burden on an agency that is already short staffed; it fails to provide any sort of treatment to address the underlying needs of the child. We are acutely aware that this is not the best thing for these kids, but we have no other options. The frustration that comes with this knowledge may actually be more harmful to the morale of our employees than the stress and exhaustion of providing 24-hour coverage. While we receive good cooperation from social services and providers like Blair Health Choices in assessing complex cases and looking for placements, there simply are not enough facilities that will take complex children and, perhaps more importantly, that will keep them. There is nothing worse than having a child sent back to us because they acted out in a way typical for a person with their diagnoses by the very place that was supposed to be helping them. It is a failure of our system and our society that this is allowed to happen and happens with such frequency. We need contracting policies enforced by the state to prevent facilities who receive taxpayer money from rejecting or ejecting kids who meet their criteria for admission.

Furthermore, to be proactive and reduce costs, an increase in mental health base funds would increase the likelihood that complex needs could be addressed in the community with services instead of requiring placement. I want to emphasize that this should be base funding and not grant funding. Grant funding requires more administrative work and cost to facilitate. I already have employees spending two hours on paperwork for every hour they spend serving families. None of us needs more paperwork. I am, once again, asking the state legislature to support and vote in favor of an increase to the mental health base funding.
