Annual Meeting: Tuesday, April 26, 2022, 9:30 A.M.

The Annual Meeting of Blair HealthChoices was held with Commissioner Erb, Commissioner Burke, Commissioner Webster, Chief Clerk Hemminger, Blair HealthChoices Executive Director Amy Marten-Shanafelt and Blair HealthChoices Director of Finance Stacey Rouch present.

Call to Order:

Commissioner Erb called the meeting to order.

Commissioner Erb introduced from Blair HealthChoices Amy Marten-Shanafelt and Stacey Rouch.

Approval of the 2021 Annual Meeting Minutes – Tuesday, April 27, 2021:

Commissioner Erb called for a motion to approve the April 27, 2021 annual meeting minutes.

Motion by Commissioner Erb, seconded by Commissioner Burke and unanimously approved to accept the minutes as prepared.

Executive Director's Comments:

Commissioner Erb invited Mrs. Marten-Shanafelt to present the Executive Director's Summary.

Executive Summary January 1, 2021 - December 31, 2021:

Mrs. Marten-Shanafelt presented the Blair HealthChoices Executive Summary to the Commissioner's outing the summary as follows:

Mrs. Marten-Shanafelt stated that HealthChoices is the Commonwealth of Pennsylvania's mandatory Medicaid managed care program administered by the Department of Human Services (DHS). She stated that the integrated and coordinated health care delivery system was introduced by the Commonwealth to provide medical, psychiatric and substance abuse services to Medicaid (Medical Assistance) recipients.

Mrs. Marten-Shanafelt stated that broad-based coordination is necessary in order to meet the complex needs of high-risk populations in the HealthChoices managed care program to assure appropriate access, service utilization, and continuity of care for those persons with serious mental illness and/or addictive diseases. She stated that the unique structure of county administered behavioral health and human service delivery systems and the counties' experience in administering behavioral health services has led to county governments being offered the right-of-first opportunity to enter into capitated contracts with the Commonwealth to manage local HealthChoices programs.

Mrs. Marten-Shanafelt stated that on July 1, 2007, the county accepted the right-of-first opportunity to manage the local program and entered into a full-risk capitation contract with the Commonwealth of Pennsylvania.

The county formed a 501(c) 3 non-profit corporation called Central PA Behavioral Health Collaborative, Inc., d/b/a Blair HealthChoices who manages the local program. She stated that Blair HealthChoices assumed full-risk for the capitation contract on July 1, 2010.

Mrs. Marten-Shanafelt stated that during calendar year (CY) 2021, Blair HealthChoices continued to subcontract with its behavioral managed care organization partner the Community Care Behavioral Health Organization. The services provided by organization include care management, provider network development, quality assurance, member services, and claims management. She stated that Blair HealthChoices provides oversight and monitoring of all of the organizations activities to ensure full compliance with its contract with DHS. As of March 2012, Blair HealthChoices became a Certified Utilization Review Entity and has since provided person-centered care management for HealthChoices members with more complex needs.

Member Demographics:

Mrs. Marten-Shanafelt stated that as of December 31, 2021 the number of Blair County residents enrolled in the HealthChoices Program was 34,802. She explained the various Categories of Aid (i.e. Temporary Assistance to Needy Families (TANF), Modified Adjusted Gross Income (MAGI), Newly Eligible, Supplemental Security Income without Medicare (SSI) and Supplemental Security Income with Medicare (SSIM).

Services:

Mrs. Marten-Shanafelt stated that HealthChoice members are eligible to receive in-plan services offered by their choice of at least two (2) service providers, as well as additional services that have been approved for use by the Blair HealthChoices Program. She outlined the In-Plan Services, the Supplemental Services and the EvidenceBased Modalities.

Utilization Summary:

Mrs. Marten-Shanafelt stated that as of March 2022 for the period of January-December 2021 the Number of Members Served was 9,385; Claim Payments \$32,473,154.00; Alternative Payment Arrangement (APA) amount paid \$2,373,590.00; Pay for Performance (P4P) amount paid \$399,595.00 and Total APA and P4P Expenditures \$2,773,185.00 Grand Total \$35,246,339.00.

Mrs. Marten-Shanafelt stated that the ** Other Supplemental Service category is comprised of supplemental services, such as Substance Use Assessments, Intensive Outpatient, Partial Hospital, Case Management as well as Children's Services Program Exceptions.

Mental Health Disorders:

Mrs. Marten-Shanafelt stated that as of March 2022 for the period of January-December 2021 the number of members served was 7,762 with total expenditures of \$21,973,189.00. She stated that the largest area of members served is 2,811 or 23.1% with depressive/mood disorders.

Substance Use Disorders:

Mrs. Marten-Shanafelt stated that as of March 2022 for the period of January-December 2021 the number of members served was 2,498 with total expenditures of \$10,499,964.00. She stated that the largest area of members served is Opioid Use Disorders at 52.8% (1,577), second is Alcohol Use Disorders 18.8% (562), third is **Other Psychoactive Drug Use Disorders 17.1% (509) fourth is Cannabis Use Disorders 9.0% (269), and fifth is Cocaine Use Disorders 2.3% (68).

Mrs. Marten-Shanafelt stated that **Other Psychoactive Drug Use Disorders include drug or alcohol psychosis, drug or alcohol withdrawal, amphetamine abuse/dependence, hallucinogen abuse/dependence, inhalant abuse/dependence, sedative-hypnotic/anxiolytic abuse/dependence, and polysubstance abuse/dependence.

Youth Members Served:

Mrs. Marten-Shanafelt stated that as of March 2022 for the period of January-December 2021 the number of members served was 2,553 with total expenditures of \$9,454,429.00. She stated that youth include HealthChoices members under age 18 and all members involved in BHRS or RTF services.

HealthChoices Financial Impact on Medicaid Spending:

Mrs. Marten-Shanafelt provided a comparison of Behavioral Health HealthChoices Impact versus the Fee-forService Model from FY 2006 to FY 2021. She stated that Fee-For-Service increased based on 12% preHealthChoices average annual growth under Fee-For-Service model.



HEALTHCHOICES


HealthChoices is the Commonwealth of Pennsylvania's mandatory Medicaid managed care program administered by the Department of Human Services (DHS). This integrated and coordinated health care delivery system was introduced by the Commonwealth to provide medical, psychiatric, and substance abuse services to Medical Assistance (Medicaid) recipients.

Broad-based coordination is required to meet the complex needs of high risk populations in the HealthChoices managed care program and assure appropriate access, service utilization, and continuity of care for persons with serious mental illness and/or addictive diseases. The unique structure of county administered behavioral health and human service delivery systems and the counties' experience in administering behavioral health services, led to county governments being offered the right-of-first opportunity to enter into capitated contracts with the Commonwealth to manage their local HealthChoices programs.


As of July 1, 2007, Blair County accepted the right-of-first opportunity to manage the local program and entered into a full-risk capitation contract with the Commonwealth. The County formed a 501(c)3 nonprofit corporation called Central PA Behavioral Health Collaborative, Inc. d/b/a Blair HealthChoices, which manages the local program. Beginning on July 1, 2010, Blair HealthChoices assumed full-risk for the capitation contract with DHS.

During operating year 2022, Blair HealthChoices continued to sub-contract with its behavioral managed care organization partner, Community Care Behavioral Health Organization. Services provided by Community Care included care management, provider network development, quality assurance, member services, and claims management. Blair HealthChoices provides oversight and monitoring of all of Community Care's activities to ensure full compliance with its contract with DHS. Since March 2012, Blair HealthChoices has been a Certified Utilization Review Entity and has provided person-centered care management for HealthChoices members with more complex needs.









Schizophrenia/Psychotic














HealthChoices Financial Impact on Medicaid Spending




FFS increase based on 12% pre-HealthChoices average annual growth under Fee-for-Service model.



Opioid Epidemic Impact on Service Delivery








Consumer Family Satisfaction

The Department of Human Services (DHS) and Blair HealthChoices values and encourages the input of consumers and families in all aspects of the HealthChoices Program and incorporates into all quality improvement efforts. In addition, we encourage input regarding the services and supports received in the mental health and drug and alcohol service system. Consumer and family feedback helps inform Providers, counties, and Behavioral Health Managed Care Organizations (BH-MCO) about how services can support recovery for adults, resilience in children and adolescents and be more effective. Consumers and families have specialized knowledge and sensitivity about how respect, dignity and responsiveness of services can affect the process of recovery and preserve resilience. Soliciting feedback on satisfaction with services empowers consumers and families and allows them to have a greater role in determining the quality of behavioral health care and recommending system improvements. Therefore, DHS requires Primary Contractors to implement a comprehensive approach for the measurement of consumer/family satisfaction by organizing a Consumer and Family Satisfaction Team (CFST). All surveyors employed by the CFST are consumers or family of consumers. The following pages summarize the information collected.

During the 2022 calendar year, 511 general purpose surveys were completed. The majority of surveys (74.6%) were completed face-to-face with the members. This yera, more surveys were completed onsite at substance use facilities, which provided a higher face-to-face percentage than in previous years.

Adult

In CY 2022, 56.5% of adults surveyed were female. Most services received were to treat substance use disorders among members between 35-44 years old.

In 2022, questions were modified to monitor treatment experiences with telehealth and access to services:

The lowest scoring question of 45.6% was the provider talking to the member about the plan for after treatment. In 2021, the score was 43.6%, which demonstrated a slight improvement in 2022. Providers have initiated changes to documentation to prompt clinicians in the discussion of aftercare treatment/planning. One provider has started a patient portal where members will have access to their treatment notes and plans.

We utilize our Provider Advisory Committee, Stakeholder Committee, Community Supports Program, and Drop-In Center, for various opportunities to share the results. We obtain feedback to improve on areas of need or identify gaps in treatment.

Family

In 2022, 51.6% of the children surveyed were female. Most of the youth surveyed were between 9-13 years old, first diagnosed 4 or more years ago, and were receiving treatment for medication management and outpatient therapy.

The lowest scoring question was concerning aftercare planning (26.3%), which is an area for further discussion. Families have expressed that, "We haven't talked about it yet," or "This is going to be ongoing." The results were shared with our Quality and Clinical Management Committee (QCMC) meeting that includes providers and members. Feedback from QCMC was given about adding a non-applicable (N/A) option to the question to exclude levels of care, such as medication management, which may be appropriate for members to receive long-term.

Vouth

In 2021, 53.0% of youth surveyed were female. Most of the youth surveyed were between 14-15 years old, with the majority of youth receiving treatment for medication management and outpatient therapy.













Telehealth Service Utilization After COVID

Telehealth as Percentage of Each Race Served in Month January - December 2022







Mental Health vs. Substance Use Telehealth Treatment as Percentage of Each Service Type in Month



Terminology

ALTERNATIVE PAYMENT ARRANGEMENT (APA)

Refers to any of the various contractual agreements for reimbursement that are not based on a traditional fee for service model. Types of arrangements include but are not limited to the following: retainer payments; case rates; and subcapitation.

AUTHORIZATION

A process that is related to the payment of claims by which a provider receives approval from Community Care to provide a particular service. Authorizations typically limit the number of units and the time in which the service can be provided. If a service requires authorization for payment, the lack of authorization will result in an unpaid claim.

BEHAVIORAL MANAGED CARE ORGANIZATION (BH-MCO)

An entity that manages the purchase and provision of behavioral health services.

CAPITATION

A set amount of money received or paid out; it is based on membership rather than on services delivered and is usually expressed in units of PMPM (per member per month) or PMPD (per member per day). Under the HealthChoices program, capitation rates vary by categories of assistance.

CLAIM

A request for reimbursement for a behavioral health service.

COMPLAINT

A process by which a consumer or provider can address a problem experienced in the HealthChoices program.

CONSUMER

HealthChoices enrollees on whose behalf a claim has been adjudicated for behavioral health care services during the reporting period.

DENIAL

A denial is defined as "a determination made by a managed care organization in response to a provider's request for approval to provide in-plan services of a specific duration and scope which (1) disapproves the request completely; (2) approves provision of the requested service(s), but for a lesser scope or duration than requested by the provider; (an approval of a requested service which includes a requirement for a concurrent review by the managed care organization during the authorized period does not constitute a denial);

or (3) disapproves provision of the requested service(s), but approves provision of an alternative service(s)."

DIAGNOSIS

A behavioral health disorder based on criteria established in the Diagnostic and Statistical Manual of Mental Disorders (DSM). The DSM is published by the American Psychiatric Association and provides a diagnostic coding system for mental and substance abuse disorders.

DIAGNOSTIC CATEGORIES

Subgroups of behavioral health disorders. This report contains the following groupings:

Adjustment Disorder – the development of clinically significant emotional or behavioral symptoms in response to an identifiable psychosocial stressor or stressors.

Anxiety Disorders – a group of disorders that includes: Separation Anxiety Disorder, Selective Mutism, Panic Disorder, Social Phobia, Posttraumatic Stress Disorder, Obsessive Compulsive Disorder, Generalized Anxiety Disorder, and Anxiety Disorder Not Otherwise Specified.

ADHD and Disorders in Children – includes Attention Deficit Hyperactivity Disorder, Conduct Disorder, Oppositional Defiant Disorder, and Disruptive Behavior Disorder Not Otherwise Specified.

Autism Spectrum Disorder is a neurological disorder that involves some degree of difficulty with communication and interpersonal relationships, as well as obsessions and repetitive behaviors.

Bipolar Disorders – a group of mood disorders that characteristically involve mood swings. This group includes: Bipolar I Disorder, Bipolar II Disorder, Bipolar Disorder Not Otherwise Specified, Mood Disorder, and Mood Disorder Not Otherwise Specified.

Conduct Disorder/Oppositional Defiant Disorder - a group of serious emotional and behavioral problems in children and adolescents. Children with conduct

disorders frequently behave in extremely troubling, socially unacceptable, and often illegal ways, though they feel justified in their actions and show little to no empathy for their victims. Children with oppositional defiant disorder have patterns of unruly and argumentative behavior and hostile attitudes toward authority figures.

Depressive Disorders – a group of mood disorders that includes Major Depressive Disorder, Dysthymia, and Depressive Disorder Not Otherwise Specified.

Schizophrenia and Psychotic Disorders – a collection of thought disorders such as Schizophrenia, Schizoaffective Disorder, Schizophreniform Disorder, and Psychotic Disorder Not Otherwise Specified.

Other Mental Health Disorders – includes Tic Disorders, Learning Disorders, Communications Disorders, and Motor Skills Disorders.

Substance Use Disorders – a group of disorders related to taking a drug of abuse. The DSM refers to 11 classes of substances: alcohol, amphetamines, caffeine, cannabis (marijuana or hashish), cocaine, hallucinogens, inhalants, PAY FOR PERFORMANCE (P4P)

P4P is an umbrella term for initiatives aimed at improving the quality, efficiency, and overall value of health care. These arrangements provide financial incentives to hospitals, physicians, and other health care providers to carry out such improvements and achieve optimal outcomes for members.

RESIDENTIAL TREATMENT FACILITY (RTF)

A self-contained, secure, 24-hour psychiatric residence for children and adolescents who require intensive clinical, recreational, educational services and supervision.

UTILIZATION

The amount of behavioral health care services used by Medicaid recipients. Utilization is based on encounter (paid claims) information.



nicotine, opiates (heroin or other narcotics), PCP, and sedatives/hypnotic/anxiolytics.

ENROLLMENT

The number of Medicaid recipients who are active in the Medical Assistance program at any given point in time.

INTENSIVE BEHAVIORAL HEALTH SERVICE (IBHS)

IBHS replaced Behavioral Health Rehabilitation Services (BHRS). The transition between BHRS and IBHS occurred between October 19, 2019 and January 17, 2021. IBHS provides supports for children, youth or young adults under the age of 21 with mental, emotional or behavioral health needs. Services can be provided in the home, school or other community setting. Services include Behavioral Consultant (BC), Mobile Therapy (MT), Behavioral Health Technician (BHT), Multi-Systemic

Therapy (MST), Community and School-Based Behavioral Health Services (CSBBH), Community Residential Rehabilitation Host Home (CRR), and Functional Family Therapy (FFT), Summer Therapeutic Activities (STAP), Therapeutic Family Care (TFC), and evaluation services.

MEMBER

Eligible Medical Assistance recipients enrolled in the HealthChoices program during the reporting period.

REINVESTMENT FUNDS

Capitation revenues from DHS and investment income that

are not expended may be used to purchase start-up costs for state plan services, development or purchase of in lieu of and in addition to services or non-medical services, contingent upon DHS prior approval of the Primary Contractor's reinvestment plan.
