## Blair County Salary Board Meeting of December 28, 2018 9:00 AM

**Call to Order:** Commissioner Erb called the meeting to order at 9:00 a.m.

**Call for Public Comment:** Commissioner Erb called for public comment on Salary Board items. There was no comment at this time.

**Approval of Minutes:** A motion was made by Commissioner Beam and seconded by Commissioner Tomassetti that the minutes from the December 13, 2018 Salary Board Meeting be approved. The motion was carried unanimously.

1. A motion was made by Controller Stickel and seconded by Commissioner Beam that effective 1/1/19, any non-union starting wage below \$10.00 per hour shall be increased to \$10.00 per hour. This includes part-time and full-time non-union employees. The motion was carried unanimously.
2. A motion was made by Controller Stickel and seconded by Commissioner Tomassetti that effective 1/1/19, all Full Time non-union employees will receive an increase equal to the largest of an increase to \$10.00 per hour OR an increase of 3% OR an increase of \$999.96 per year. The motion was carried unanimously.
3. A motion was made by Controller Stickel and seconded by Commissioner Tomassetti that effective 1/1/19, all Part Time non-union employees will receive an increase equal to the larger of an increase to \$10.00 per hour OR an increase of 3%. The motion was carried unanimously.

All increases have been included in the adopted 2019 budget.


