Call to Order: Commissioner Erb called the meeting to order at 10:30 a.m.

Call for Public Comment: Commissioner Erb called for public comment on Salary Board items. There was no comment at this time.

Approval of Minutes: A motion was made by Commissioner Tomassetti and seconded by Controller Stickel that the minutes from the July 11, 2019 Salary Board Meeting be approved with the following correction: The title for the Probation Aide I re-created to replace Nicole Keller should be Probation Officer Aide I. The motion was unanimously carried.

Positions:

Adult Parole and Probation

Requested by Elizabeth Doyle, President Judge

Parole and Probation Officer: A motion was made by President Judge Doyle and seconded by Controller Stickel to re-create four positions as UMWA-Court, Non-Exempt (Hourly,) Full-time at 37.5 hours per week, with a starting rate of \$12.57 hourly, \$942.45 estimated bi-weekly, and \$24,503.70 estimate annually. These vacancies are due to the resignations of Brian Porter effective 05/31/19, Kaitlyn Eger effective 07/05/19, Jedidiah Price-Yuknavich effective 08/02/19, and Angela Hewett effective 08/02/19. The actual starting rate is \$12.5660 hourly. The motion was unanimously carried.

Emergency Management

Requested by Cris Fredrickson, Manager/Supervisor

Administrative Assistant: A motion was made by Controller Stickel and seconded by Commissioner Tomassetti to re-create this position as Non-Union, Non-Exempt (Hourly,) Full-time at 35 hours per week, \$11.77 hourly, \$823.90 estimated bi-weekly, and \$21,421.40 estimated annually. This vacancy is due to the termination of Carrie Wilkinson, effective 07/15/2019. The motion was unanimously carried.
