Blair County Salary Board Meeting of April 21, 2021 2:00 PM By Conference Call

Call to Order: Commissioner Erb called the meeting to order at 2:00 p.m.

Commissioner Erb explained the ground rules for today's teleconference. Only voting members of the Salary Board may leave their telephones unmuted during the entire meeting, but we would request each avoids excess noise from your location. <u>Clerk Typist I</u> Prothonotary Patton moved to re-create this position. This position is UMWA-Court, Non-Exempt (Hourly). Full-Time at 35 hours per week with an hourly rate of \$10.5063, \$735.44 estimated bi-weekly, \$19,121.47 estimated annually. This vacancy is due to the resignation of Clara Rininger effective 04/16/2021. Commissioner Webster seconded the motion and it was unanimously carried.

<u>Clerk Typist I</u> Prothonotary Patton to re-create this position. This position is UMWA-Court, Non-Exempt (Hourly). Part-Time at 29 hours per week with an hourly rate of \$10.5063, \$609.37 estimated bi-weekly, \$15,843.50 estimated annually. This vacancy is due to the termination of Brittany Parshall effective 03/26/2021. Commissioner Webster seconded the motion and it was unanimously carried.

<u>Department Clerk I</u> Commissioner Burke moved to re-create this position. This position is UMWA-Court, Non-Exempt (Hourly). Full-Time at 35 hours per week with an hourly rate of \$10.5063, \$735.44 estimated bi-weekly, \$19,121.47 estimated annually. This vacancy is due to the resignation of Erin Bennett effective 04/08/2021. Controller Stickel seconded the motion and it was unanimously carried.

Records Management

Records Management Archivist Commissioner Webster moved to re-create this position. This position is UMWA-Residual Unit, Non-Exempt (Hourly). Part-Time at 19 hours per week with an hourly rate of \$10.5063, \$399.24 estimated bi-weekly, \$10,495.79 estimated annually. This position is not to exceed 999 hour per anniversary year. This vacancy is due to the resignation of Libby Matthews effective 04/28/2021. Commissioner Burke seconded the motion and it was unanimously carried.

Commissioners' Office

Assistant County Administrator Commissioner Erb moved to re-create this position. This position is Non-Union, Exempt (Salary). Full-Time at 35 hours per week. The current starting range, set at the 09/12/2016 Salary Board Meeting, is \$1,346.16 to \$1,538.47 bi-weekly, \$35,000.16 to \$40,000.22 annually. Adjusting for the annual increases, the proposed range is \$1,508.20 to \$1,723.66 bi-weekly, \$39,213.14 to \$44,815.16 annually. This vacancy is due to the resignation of Scott Simmons effective 02/26/2021. Commissioner Webster seconded the motion and it was unanimously carried. Chief Clerk Hemminger confirmed with Commissioner Erb and Commissioner Webster the proposed range of \$39,213.14 to \$44,815.16 annually was approved.

There being no further business to discuss, the meeting was adjourned at 2:12 p.m.
