Mr. Schultz stated that the Memorandums of Understanding (MOU's) are an annual request.

Discussion followed.

Blair County Court Administration:

Scott Schultz requested approval for the submission of a 2020 Capital Indigent Defense Grant Application #32649 to the Commonwealth of Pennsylvania, Pennsylvania Commission on Crime and Delinquency (PCCD) in the amount of \$20,000.00 for a Capital Mitigation Specialist/Sentencing Advocate.

Mr. Schultz stated that any awarded grant funds will support the Public Defender's Office in defending capital indigent cases to the best of their abilities without a financial burden to the county.

Discussion followed.

Scott Schultz requested approval for the submission of a FY 19/20 DUI Court Discretionary Grant Application to the Administrative Office of Pennsylvania Courts (AOPC) in the total amount of \$8,449.40, for enhancement of the County's DUI Court.

Mr. Schultz stated that this is an annual submission request. He stated that currently there are 49 participants in DUI court and any awarded funds will be used to enhance the DUI Court with necessary supplies, program incentives, staff travel and training.

Discussion followed.

Scott Schultz requested approval for the submission of a FY 19/20 Drug Court Discretionary Grant Application to the Administrative Office of Pennsylvania Courts (AOPC) in the total amount of \$8,450.00, for enhancement of the County's Drug Court.

Mr. Schultz stated that this is an annual submission request. He stated that currently there are 77 participants in Drug court and any awarded funds will be used to enhance the Drug Court with necessary supplies and program incentives.

Discussion followed.

Fort Roberdeau:

Glenn Nelson requested approval of six (6) individual advertising contracts for calendar year 2020 with Barash Media Publications (Town & Gown, Arts Festival Guides and Blair County Chamber Guide), in the total amount of \$2,755.00 to be paid out of the Fort's advertising budget.

Discussion followed.

Blair County Park & Recreation Advisory Board:

Melissa Harpster requested approval to award the following six (6) 2020 Blair County Park & Recreation Grant Awards in the total award amount of \$18,000.00 to be paid from the Park & Recreation 035 Reserve Account:

Spring Cove Youth Baseball	\$3,000.00	Purchase 12 x 18 storage shed.
Central Blair Recreation Commission	\$3,000.00	Remodel Press Box at Veterans Memorial Field
Morrison's Cove Memorial Park	\$3,000.00	Improvements to outdoor basketball court and replace obsolete streetlights and add an additional LED streetlight.
Altoona Housing Authority	\$3,000.00	Repair, sealcoat and line painting of basketball court surface at Fairview Hills.
Northern Blair Co. Recreation Center	\$3,000.00	Purchase 2 full-size regulation soccer goals.
Greenfield Township	\$3,000.00	Restroom area ADA compliant @ Claysburg Community Park.

Solicitor Karn stated that in reviewing the grant applications he has concerns about two and possibly three of the applications received.

Solicitor Karn explained the details of Court Order which set forth the revenue generated by the rent of then Boyertown, now Lakemont Park by the County. The grant award funds are generated from the rent received from Lakemont Park. He stated, in the past, the Court has ruled that the County could not use the rent received from Lakemont Park to fund construction of the Blair County Ballpark because it was deemed as a private, for-pay space as opposed to an open for general public use space for recreation.

Solicitor Karn stated the grant application requires those organizations applying for a grant to be open to the general public, free of charge. He stated that open to the general public means that the recreation area or the facilities are available for use by the general public free of charge when they are not in use by leagues, if any, or those who have reserved the location in advance. Organizations may charge a fee for a reservation made by the general public; however the recreation area or facility may not be always used by leagues or always reserved for private use. The organization may maintain operating hours and secure the premises during non-operating hours, but a significant portion of their operating hours must be for general public use and free of charge.

Solicitor Karn stated he had a few concerns with the applications received. While the field used by Spring Cove Youth Baseball as a whole is open to the public, he does not see how their project of a storage shed will benefit the general public. The press box project at Vet's Field seems to fall within the same category; while the field may be open to the public, the press box is not. The Northern Blair Recreation Center soccer goals project depends on whether the goals are left on the field so anyone can use them or whether they are restricted for use by paying participants only.

Mrs. Harpster stated that she would address Solicitor Karn's concerns with the Park and Recreation Advisory Board Members at their March 5 meeting.

Discussion followed.
