The Commissioner's confirmed that nothing is finalized but a piece of land has been identified and we are waiting on a contract. An assessment of the property is still needed for access of utilities. This is a priority still for the Commissioners and Prison Board.

Approval of Minutes from November 13, 2025 Meeting: A motion was made by Commissioner Kessling and seconded by Controller Stickel to approve the minutes from the November 13, 2025 Prison Board Meetings. The motion was unanimously carried.
