## Blair County Salary Board Meeting of June 21, 2023

**Call to Order:** Commissioner Erb called the meeting to order at 2:30 p.m.

**Call for Public Comment:** Commissioner Erb called for public comment on Salary Board items. There were no comments.

**Approval of Minutes:** A motion was made by Commissioner Webster and seconded by Commissioner Erb that the minutes from the June 7, 2023 meeting be approved. The motion was unanimously carried.

**Public Safety-911**

**Requested by Coordinator Sue Ammerman**

Part-Time Telecommunicator Melena Kogler, Human Resources Manager, stated this position is UMWA-Residual, Non-Exempt (Hourly), Part-Time (limited to 1500 hours per anniversary year) at 29 hours per week with an hourly rate of \$16.30/hour (set by the Collective Bargaining Agreement), The original agenda stated "with an hourly rate within the range of \$16.29/hour to \$24.83/hour". Rate ranges do not apply to union positions. Commissioner Webster moved to create this position. Commissioner Burke seconded the motion and it was unanimously carried.

**Social Services**

**Requested by Director Tricia Maceno**

Mental Health Program Coordinator Commissioner Erb moved to re-create this position within the hiring range of the S11 pay grade (\$52,649.33 to \$56,861.28 annually). This position is Non-Union, Exempt (Salary), Full-Time at 35 hours per week. The wages and benefits are reimbursed at 100% by the state. This vacancy is due to the retirement of Theresa Rudy effective 08/11/2023. Commissioner Webster seconded the motion and it was unanimously carried.
