**Call to Order:** Controller Stickel called the meeting to order at 9:01 a.m.

**Approval of Minutes:** A motion was made by Treasurer Carothers and seconded Commissioner Webster by to approve the minutes from the May 7, 2025 Retirement Board meetings. The motion was unanimously carried.

**Rebalancing Proposal:** The Controller's Office determined that \$60,000 is needed from the Fund to meet June distribution payments. A motion was made by Treasurer Carothers, seconded by Commissioner Webster, and unanimously carried to approve the proposed rebalancing.

**Administrative Fees:** There were none.

**Litigation Checks:** There were none.

**Retirements:** Attachment C were made into a motion for approval by Controller Stickel and seconded Treasurer Carothers. Commissioner Burke: I did not think the retiree (Snowberger) had worked at the County long enough to "retire". She has only been with the County since 2022. Controller Stickel: She has met the designated age requirement even if she does not have the years and will receive a very small retirement. The motion was unanimously carried.
