Commissioner Burke noted her abstention on the payment of invoices to James and Julia Burke included on one-1 of the listed Warrant Lists due to a conflict of interest.

Motion by Commissioner Webster, seconded by Commissioner Burke and unanimously approved to adopt Resolution 492-2020.

Staff Reports & Special Business:

Covid-19 Weekly Update:

Mark Taylor stated that since his update last Tuesday, Blair County had an additional 850 positive cases and and additional 25 deaths. He stated that the total number of positive cases since the beginning of the Pandemic is 5,923 and total deaths 88.

Mr. Taylor stated that the area hospitals have seen a significant increase in COVID-19 cases; however, the number of admissions stabilized. He stated that the hospitals continue to monitor the situation and are currently still able to handle all cases.

Mr. Taylor stated that there is still increasing outbreaks in area long-term facilities with staffing concerns. He stated that the increase in the number of positive cases within the prison continues to be closely monitored for both the health and well-being of not only the inmates by the employees as well.

Mr. Taylor stated that there is no new update on the availability of a vaccine. He stated that there is concern with the number of first responders testing positive with the virus; however, there has been no report of any interruption of services.

Discussion followed.

GIS Department:

Grant Wills requested approval of two (2) renewal ArcGIS Software Maintenance Agreements between the County of Blair and Environmental Systems Research Institute, Inc., (ERSI). One of the agreements will be for use by the Geographic Information Systems (GIS) Department and the Assessment Office, in the amount of \$15,800.00 for five (5) ArcGIS for Desktop Advanced Concurrent Use Licenses, one (1) ArcGIS Spatial Analyst for Desktop Concurrent Use License, and two (2) ArcGIS for Server Enterprise Standard Licenses for the period of December 31, 2020 through December 30, 2021; and the second agreement is for use by the 911 Operations Center, in the amount of \$1,500.00 for one (1) ArcGIS for Desktop Standard Concurrent Use License for the period of December 31, 2020 through December 30, 2021.

Mr. Wills stated the agreements fall within the current CoStars Contract. He stated that three (3) departments cover the costs associated with the agreements: GIS \$12,000.00, Assessment Office \$3,600.00 and Emergency Services \$1,500.00 (which is 100% eligible for reimbursement by PEMA).

Mr. Wills stated that the cost for Emergency Services reflects a decrease of \$5,000.00 from last year due to an upgrade in the Computer Aided Dispatch (CAD) system which deceased the need for one (1) of their licenses.

Discussion followed.

Mr. Taylor stated that the Letters of Authorization are necessary in order to facilitate the transition to NG911 services and the termination of the Legacy 911 telecommunication services.

Mrs. Rudy stated that the Letters of Agreement describe the provider agency responsibilities, the school district responsibilities and the conflict resolution process for the student assistance program mental health liaison.

She stated that the Letters of Agreement are renewed each fiscal/school year and that there is no funding referenced in the Letters of Agreement.

Discussion followed.

Prothonotary Office:

Robin Patton requested approval of a one-year Service Agreement Extension between the County of Blair, Blair County Prothonotary and MBS Service, for two (2) Lektrievers and (7) Kompact Moveable Shelving Systems, in the amount of \$2,331.00, to be paid from the Prothonotary's Automation Fund, for the period of January 1, 2021 through January 1, 2022.

Ms. Patton stated that the agreement is an annual renewal and that the rate remains the same as last year. She stated that the cost associated with the agreement would be paid from the Prothonotary's Automation Fund.

Discussion followed.

Blair County Park and Recreation Advisory Board:

Joe Keller requested approval to advertise an open application period for funding of acquisition, development, and rehabilitation projects from the Blair County Parks and Recreation Grant Program, in a total amount not to exceed \$20,000.00 from the Park and Recreation Reserve Account #035, with the maximum amount of each grant awarded up to and not exceeding \$3,000.00.

Mr. Keller stated that awarded grant funds are to be used to construct new recreational areas, add improvements to existing facilities, and restore or replace obsolete equipment. He stated that the intent of the grant program is to provide permanent improvements.

Mr. Keller stated that facilities applying for grant funding must be free and open to the general public, meaning that the facility is available for use by the general public when otherwise not in use.

Motion by Commissioner Erb, seconded by Commissioner Webster and unanimously approved to adopt Resolution 493-2020.

Blair County Prison:

Chief Clerk Hemminger requested approval of a Food Preparation Contract by and between the County of Blair and Prime Sirloin pursuant to Resolution Number 122-2020 for preparation of food for meals for the inmates at Blair County Prison should an emergency arise wherein individuals who have tested positive for COVID-19 or who are required to quarantine due to potential exposure to COVID-19 such that the entire preparation of food for meals for the inmates may become too difficult to undertake in the normal course for a flat fee per menu item prepared in accordance with the price schedule attached as Exhibit C to said contract.

Mrs. Hemminger stated that due to an emergency need for food preparation at the prison due to the number of COVID-19 cases within the prison, Prime Sirloin has been providing excellent service to the prison since dinner on December 4, 2020. She stated that the contract is pending minor revisions and receipt of insurance endorsements.

Mrs. Hemminger requested that the board consider taking action on today's request pending receipt of the revised contract and the proper insurance endorsements.

Discussion followed.
