Old Business:

 Janice Meadows requested approval of a Transportation Agreement between the County of Blair, on behalf of the Blair County Court of Common Pleas/Court Administration and Fullington Trailways LLC, for Juror Transportation from the Antique Depot Parking Lot, 1401 2nd Avenue, Duncansville, PA to the Blair County Courthouse 423 Allegheny Street, Hollidaysburg, PA at the cost per bus per day of \$305.00 for the remainder of 2020 and all of 2021. Total cost for the remainder of 2020 is \$0 after reimbursement from CARES approval and \$7,930.00 for 2021.

Mrs. Meadows stated that funds were budgeted in the 2020 budget for two buses for six criminal and one civil jury selection at the rate of \$305.00 per bus or a total of \$4,270.00. However, the county has exceed the amount put in the budget due to the COVID-19 Pandemic. Because of the Pandemic, she was anticipating some reimbursement of funds through the CARES Act allocation received by the county for 2020.

Discussion followed.

Mrs. Meadows stated that Solicitor Karn has reviewed the agreement and the certificate of liability insurance; however, the county is still waiting on the appropriate insurance endorsements that need to accompany the certificate of liability insurance.

Mrs. Meadows stated that she would check with Fullington Trailways regarding increasing the number of passengers from 12 to 22 per bus; however, having only one bus is going to slow transportation of 50 to 80 people.

Discussion followed.

<u>Resolution 404-2020</u>: A resolution approving a Transportation Agreement between the County of Blair, on behalf of the Blair County Court of Common Pleas/Court Administration and Fullington Trailways LLC for Juror Transportation from the Antique Depot Parking Lot to the Blair County Courthouse at the cost per bus per day of \$305.00 for the remainder of 2020 not to exceed \$4,270.00.

Motion by Commissioner Burke, seconded by Commissioner Webster and unanimously approved to adopt Resolution 404-2020.

2. Janice Meadows requested approval of two-2 proposals received from Morefield Communications for equipment and installation of an intercom system integrated into the courts telephone systems at District Court 24-3-01 (MDJ Miller) and District Court 24-3-03 (MDJ Aigner), in the total amount of \$748.15 per court.

Mrs. Meadows stated that Solicitor Karn has reviewed the proposals received from Morefield Communications and upon review; he has requested several changes to the proposals. She stated she has not received the reviewed proposals back from Morefield Communications.

Mrs. Meadows stated that there were concerns raised by some of the MDJS's regarding the use of the proposed buzzer/paging system. She stated that if CARES Act Funding is an issue for this project, there are funds available through several accounts within the courts that could be used for this project as well as the possibility of funds from a security grant through AOPC.
