1875 Courtroom Judges' Portraits Restoration of Frames:

Commissioner Erb continued discussion concerning a proposal received from Conservator John Rita in the total amount of \$2,100.00, to restore and re-gild, seven (7) portrait frames, including polishing and re-lacquering of the brass nameplates and provision of the proper hanging hardware. Work to be completed within the first half of 2020.

Commissioner Erb stated that while attending a recent engagement he had the pleasure of speaking with Michael McLanahan, Chairman of the Board of the McLanahan Corporation. He stated that through their conversation, they had talked about the courthouse restoration project and the restoration of the 1875 Courtroom Judge's Portrait Frames, and that by the end of their conversation Mr. McLanahan stated that he would like to pledge to pay for the restoration of the frames.

Commissioner Erb stated that Mr. McLanahan was in attendance at today's meeting and he invited Mr. McLanahan to the podium to speak briefly, as to why he has graciously pledged to pay for this project.

Mr. McLanahan stated that the McLanahan Corporation would turn 185 years old on Monday, making them 11 years older than the county. He stated that his family is related to four of the judges in Blair County history and that he is glad to be able to pledge to cover the cost of the restoration of the judges' portrait frames.

Mr. McLanahan stated that the commissioners are to be commended for their efforts in the restoration of the courthouse stating, "It is an outstanding piece of work."

Commissioner Erb as well as follow Commissioners Tomassetti and Beam extended their thanks and appreciation to Mr. McLanahan for his generosity.

Commissioner Beam shared a few brief words stating that he has been able to come to terms with the fact that he was not re-elected for a third term and that the eight years that he was privileged to serve were "an unbelievable ride."
