Call to Order: Commissioner Erb called the meeting to order at 10:30 a.m.

Call for Public Comment: Commissioner Erb called for public comment on Salary Board items. There was no comment at this time.

Approval of Minutes: A motion was made by Commissioner Beam and seconded by Commissioner Tomassetti that the minutes from the February 28, 2019 Salary Board Meeting be approved. The motion was unanimously carried.

Commissioner Erb noted that Chief Deputy Controller Angela Wagner was present at today's meeting in Controller Stickel's absence.

Positions:

Highway Department Summer Staff: Rocky Greenland requested to re-create 16 Summer Help positions as Non-Union, Non-Exempt, and Temporary for 37.5 hours per week for a period of 12 weeks (May through August 2019,) at the rate of \$10.00 per hour, \$750.00 bi-weekly, and \$4500.00 annually. These positions are not eligible for Full-Time benefits because they are temporary. Funding for these positions will come from the Public Works General Funds, Park & Rec Funds, Public Works Liquid Fuel Fund and The Public Works Bridge Fundings. A motion was made by Commissioner Beam and seconded by Commissioner Tomassetti that the positions be re-created. The motion was carried unanimously. It was noted that family members of county employees who apply for these positions will be given preference.
