# 10. STAFF REPORTS & SPECIAL BUSINESS

# A. Children, Youth and Families: (Jim-nwk reviewed)

- a. Requesting approval of a State Fiscal Year 21/22 to 22/23 Plans of Safe Care Support (POSCS) Grant Agreement between the County of Blair, Blair County Children, Youth and Families (CYF) and the Pennsylvania Department of Human Services, in the allocated amount of \$60,000.00, for prevention, assessment, investigation, prosecution and treatment activities targeted to address child abuse and neglect, for the period of January 1, 2022 through June 30, 2023.
- b. Requesting approval of Addendum #3 to the Statement of Work (SOW) dated January 4, 2021 attached to the County of Blair Terms and Conditions attached to the aforesaid Agreement as Appendix A between the County of Blair, Blair County Children, Youth and Families and CAI to add another 120 hours of Fiscal Consultancy Services at the blended hourly rate of \$88.13 or a total of \$10,576.00 for the period of October 1, 2021 through December 31, 2021. The current SOW allows up to 420 hours for Fiscal Consultancy Services totaling \$37,014.00. Addendum #3 only increases these hours; no other changes are made to the January 4, 2021 or the May 5, 2021 Statements of Work, Terms and Conditions or Appendices A and B thereto or to the Addendum dated September 14, 2021.
