Commissioner Tomassetti presented continued discussion and summary for completion of repairs and restoration of the 1875 courtroom.

Commissioner Tomassetti stated that three (3) items need to be considered for the completion of repairs and restoration of the 1875 courtroom. He stated that the first item for consideration is Change Order #CO-AMC2 received from Albert Michaels Conservation for labor and materials for the additional work in the 1875 Courtroom #2 in the total amount of \$124,969.68 as listed below:

- \$22,699.66 decorative art finishes in the recess area behind the judge's bench,
- \$25,996.69 restore hard wood flooring beyond the jury box in the rear of the courtroom.
- \$2,600.00 restore the front courtroom doors,

- \$5,296.78 fabricate, install and finish oak millwork and new doors in rear of courtroom,
- \$68,376.55 restore the wood wainscot.

Discussion followed.

Commissioner Beam asked if it was permissible to break the voting on the adoption of the Change Order into two (2) votes, the first vote for the approval of the decorative art finishes in the recess area behind the judge's bench in the amount of \$22,699.66; and a second vote for all of the other remaining items listed on the Change Order totaling \$102,270.02.

County Administrator Schmitt stated that two (2) votes would be permissible.
