Proclamation to Proclaim September 2019 as Recovery Month

WHEREAS, behavioral health is an essential part of one's personal welfare and overall wellbeing; and

WHEREAS, prevention education of substance use disorders work, treatment is effective, and people with these disorders can attain healthy lifestyles and achieve rewarding lives in recovery. By seeking help those seeking recovery can embark on a new journey toward enhanced health and overall wellness; and

WHEREAS, encouraging relatives and friends of individuals with substance use disorders to implement preventative measures, recognize signs of the problem, and guide those in need to the appropriate treatment and recovery support services; and

WHEREAS, according to the Drug Enforcement Administration in 2018 of the persons with an active substance use disorder there were 4492 Pennsylvanians, and specifically 25 Blair County Residents that resulted in overdose deaths. We must continue to reach out to the communities and encourage those untreated to seek help; YOU ARE NOT ALONE and

Salvation Army/State Food Purchase Program (SFPP):

Jim Brown requested approval of the submission of the County of Blair State Food Purchase Program (SFPP) Expense and Data Report for FY 2018/2019 to the Pennsylvania Department of Agriculture.

Mr. Brown stated that this is a required submission to the Pennsylvania Department of Agriculture. He stated that for FY 2018-2019 the total dollar amount of commodities was \$178,066.57 for 217,498.7 pounds at an average price of \$0.82 per pound.

Discussion followed.

Blair County Emergency Management Agency:

Cris Fredrickson requested approval of a contract between the County of Blair, Blair County Department of Emergency Services and Rave Mobility Safety, for integration of the Integrated Public Alert and Warning System (IPAWS) into the current Reverse 911 Services, for a one-time setup fee not to exceed \$1,500.00, for integration and support. One-time setup fee will be paid for 100% by grant and Act 165 monies.

Mrs. Fredrickson stated that integration of the Integrated Public Alert and Warning System (IPAWS) into the current Reverse 911 Services system will allow for important emergency alerts to be sent by the Federal Emergency Management Agency (FEMA) regardless of whether or not and individual has registered their phone number for such alerts.

Discussion followed.

Ms. Bruich stated that Rite Aid Corporation will administer influenza, tetanus and pneumonia immunizations to county employees and their dependents covered under the Cigna healthcare. Rite Aid will bill Cigna directly for the immunizations administered.

Ms. Bruich stated that Empower3 will administer the influenza, tetanus and pneumonia immunizations to county employees and their dependents that are covered by Empower3 Center for Health, LLC as part of the Direct Pay Program.

Ms. Bruich stated that immunizations will be given at the courthouse on an upcoming date to be announced. She stated that if you are unable to attend the upcoming session those enrolled in Empower3 can have the immunizations given at an Empower3 office location and those enrolled in Cigna, can go to any Rite-Aid location or see their primary care physician to receive the immunizations at no cost.

Ms. Bruich stated that both agreements have been reviewed by the county solicitor.
