Commissioner Burke stated that although she is not completely satisfied with the services provided by East Coast in terms of timeliness, she feels that the salary study presented by East Coast is the product that the prior board was looking for.

Commissioner Burke stated that she does not like feeling as though she was backed into a corner when it comes to entering into a contract; however, at this time she feels that she has no choice but to agree entering into the contract to continue to move the project forward and to avoid further delays; citing 3 departments who need work done before hiring.

Commissioner Burke stated that it is going to be necessary to maintain the study and she will advocate that the board seek other options on how to maintain the study or explore how to develop the expertise to maintain it internally, but right now, she feels that entering into the contract is the best course of action for the county.

Commissioner Webster echoed Commissioner Burke's comments and stated that she believes the county now has a good basis and a comprehensive plan to move forward with calling the salary study "a finished product". She stated that she believes the unhappiness with the study comes from focusing on the person holding the job, rather than the job's tasks and skills.

Commissioner Erb stated that for the most part he agrees with Commissioners Burke and Webster's comments; however, he stated that people want the salary study reopened and redone and that is not going to happen. He stated that the board has control over the contract and can cancel it if necessary.

Motion by Commissioner Erb, seconded by Commissioner Webster and unanimously approved to adopt Resolution #010-2021.
